## Project Description

---

Saint Joseph's Mercy Care Services (SJMCS) provides primary care, education, and social services to Atlanta's medically underserved.

### Services

Services are delivered week days via five vans, a mobile clinic, eight fixed site clinics, and donated sites in health departments, churches, nonprofit agencies, and apartment complexes. SJMCS places special emphasis on meeting the needs of women and children and on prevention/treatment of infectious diseases. Paid and volunteer staff provide services at approximately 40 locations. Mobile medical teams provide primary health care, health education, immunizations, HIV testing, treatment, and counseling, EIC primary care, women's health, treatment of STD's, and social services. Substance abuse services are provided by Fulton and DeKalb Counties, Georgia State Dept. of Human Resources, and private, nonprofit halfway houses.

### Linkages

Referrals and ancillary services are provided at Grady Hospital and other local hospitals and mental health centers. Supplemental health services are referred to community health centers and pro-bono volunteers.
