

COVID-19 Funding Uniform Data System (UDS) Reporting Guidance

Health centers directly received funding from a variety of sources designed to aid the Federal response to the COVID-19 pandemic. The tables below outline common funding sources administered to health centers and where they should be reported in the UDS Report. Health centers should report the full amount drawn down, regardless of how much was spent during the calendar year.
